- FIA WRC2 Challenger Championship for Drivers and Co-Drivers
- FIA WRC2 Championship for Teams
- FIA WRC Masters Cup for Drivers and Co-Drivers
- FIA WRC3 Championship for Drivers and Co-Drivers

4.2. Closing Date for Entries

4.3. List of Entry Fees

Entry Fee Invoices

It is reminded that the entry form must be accompanied by the total entry fees or by an appropriate receipt. Invoices for entry fees will be automatically issued and sent out for each entry (competitor's name and address). Competitors requiring an invoice before payment is made must inform the organiser in due time so that the competitor can comply with the payment conditions.

→ Important Note:

Entries paid by a foreign company with a tax ID number and with business seat in a foreign country may be paid EXCLUSIVE OF VAT (reverse charge), provided that the INVOICE ADDRESS as well as the RESPECTIVE TAX ID NUMBER are indicated TOGETHER WITH THE ENTRY FORM.

Invoices/ receipts for additional materials/ facilities will only be issued upon request.

4.4 Entries Acceptance Criteria

The maximum number of entrants will be 50. If more than 50 entries are received the organiser reserves the right to convene a panel of representatives of FIA, WRC Promoter and ASN's of the organising countries to decide which entries among the non-priority crews will be accepted. Such decisions will be at their absolute discretion and may be made based on any criteria they decide.

4.5 Entry Procedure:

Manufacturers, P2 and P3 competitors who wish to score points in FIA Championships, must make their entries by using the electronic standard rally entry form for their championships available in the FIA application at <https://registrations.fia.com/rally>.

Any Non-priority Competitor wishing to take part in Rally Saudi Arabia 2026 must register and fill in the electronic entry form published at <https://registrations.fia.com/wrcsau> duly completed before the closing date for entries. In addition to submitting the online entry form to the FIA, the competitors are also required to send the following documents to contact-us@saudimotorsport.com before the closing of entries. The entry application will only be accepted if accompanied by:

- Proof of payment of the total amount of entry fees
- Copy of the International Competitor licenses
- Copies of the Driver and Co-driver international competition licenses
- ASN authorisation for all foreign drivers and co-drivers
- Copies of the Driver and Co-driver passports or identity cards
- Copies of the Driver and Co-driver driving licenses
- One passport photo for driver and co-driver
- Copy of the first page of the car homologation certificate (not for Rally1 cars)
- Copies of the car's registration papers.
- Copies of the insurance cover (third parties) for the rally car
- Copy of the entry form duly signed. By entering the rally, the competitor and the crew submit themselves to the sporting jurisdictions specified in the 2026 FIA International Sporting Code and its appendices, the 2026 FIA WRC Sporting Regulations and the event Supplementary Regulations (2026 FIA WRC Sporting Regulations, Art. 22.5).

Cheques are not accepted. Any bank charges and exchange fees (if applicable) incurred must be paid by the competitors in addition to the respective fee. Please ensure that the competitor’s name is included as reference on all bank transfers.

It is compulsory to mention the account holder on your bank transfer documents.

Entry fees will be refunded in full only:

- To candidates whose entry has not been accepted
- In the case of the rally not taking place

The organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proven case of force majeure. This must be applied for in writing (contact-us@saudimotorsport.com), giving the reason of withdrawal, before the start of administrative checks, including the competitor's bank details.

In all other cases, no entry fees will be refunded.

4.9. Advertising Regulations

- Advertising content must not include political, religious, or socially sensitive material, and must not be offensive or abusive in nature.
- Gambling and betting advertisements are strictly prohibited under Saudi law.
- Tobacco advertising is not permitted, in line with national health regulations and government restrictions.

Non-priority drivers' attention is drawn to the FIA WRC Sporting Regulations, Art. 13.2 which states that all drivers with a 4WD car must use tyres from the nominated tyre supplier, as defined in the Supplementary Regulations of the rally. On the other hand, Art. 13.3 allows the use of any make of tyres for non-priority drivers in 2WD cars, provided they all come from the same tyre supplier. For more details, contact the organiser.

4.10.1 FIA Fuel and Fast Couplings

Refuelling will be located in Service Park Jeddah (starting from Shakedown), as well as near Khualis General Hospital (Sections 1 and 2), at 17.3km from the end of special stage 8/11 Wadi Al matwi near Hada A`Sham R/A (Sections 3 and 4), and 2.0 km from the end of special stage 14 Asfan (Section 6).

Cars driven by Priority drivers must be fitted with FIA fuel sample couplings for taking fuel samples (see FIA Technical List No. 5). All cars must be fitted with FIA-specified refuel couplings (manufacturer: Stäubli, model: SPT 127 658 LJV). Also, see FIA WRC, Art. 62.

4.10.2 Safety Fuel Tanks

Competitors' attention is drawn to the prescriptions of the FIA ISC, Appendix J, Art. 253-14, which states that all cars in groups N and A must be fitted with an FIA approved safety fuel tank. For car in other groups, please see technical regulations of the group concerned. Cars homologated under Rally5-Kit regulations may use their original, unmodified tanks.

The use of FIA fuel is obligatory for all priority drivers (FIA WRC, Art. 62.1.1).

As per FIA WRC regulations Art. 62.2.1, no later than 10 weeks prior to the event (see Art. 3), the competitors must notify their fuel requirements to the sole supplier as nominated by the FIA. More information on the nominated fuel supplier will be given in the Supplementary Regulations of the rally, at the latest.

4.10.3 Dispensing of FIA Fuel

For sporting, environmental and safety reasons, during the rally the fuel must be dispensed from a single source. Thus, all cars driven by a priority driver must use this centralised refuel service. The price of the fuel, including the refuel services at the site of the event, will be given in the Supplementary Regulations of the rally, at the latest.

5.1 Service Park Location

There will be a single Service Park for the WRC Saudi Arabian Rally 2026, located at the Car Parking

- Jeddah Corniche Circuit in the heart of Jeddah. This venue will host the Rally HQ will be located in the pit buildings at the Jeddah Corniche Circuit.

All modern facilities will be available for use by competitors, officials, and media representatives throughout the event.

For teams using trucks with tent extensions or other temporary structures, please note that these must comply with all local regulations regarding structural safety and temporary building approvals. Inspections by local authorities are to be expected.

It is essential to follow legal requirements related to the notification and approval of such temporary structures as outlined in the local Building Code. For assistance, please contact SMC or SAMF for guidance.

Service Park Regulations – WRC Saudi Arabian Rally 2026

- **Vehicle Washing:** Washing of trucks or any other vehicles inside the Service Park is strictly prohibited.
- **Wastewater Management:** All waste and wastewater tanks must be emptied prior to entering the Service Park. In exceptional cases where this is not possible, the organiser may provide disposal services. These will be charged at €100 per m³, plus €300 for transport, excluding VAT.
- **Parking Regulations:**
 - **Auxiliary team vehicles** may be parked in the designated large parking area adjacent to the Service Park.
Parking any team vehicle within the Service Park is strictly forbidden. Illegally parked vehicles will be immediately towed, and the team will be charged €300 plus applicable taxes, payable on the spot.
- **Team-Related Vehicles:** Vehicles displaying official team stickers (e.g. service cars, recce cars, manufacturer meteo crews, route note cars) must be parked in the designated team parking area.
- **Joint Service Area Requests:** Teams wishing to share a service area with another competitor must notify the organiser by the deadline stated in Point 3. Please note that while all efforts will be made, not all requests can be accommodated.
- **Drone Policy:** The Service Park is a strict no-fly zone for drones throughout the event.

5.3 Service Park Facilities

- b) Additional car(s) as per Appendix VI: Depending on available space after allocation pursuant to a) above, on a first-come-first-serve basis.

5.4.2 Support Championships (WRC2 / WRC3):

- a) Space strictly in compliance with Appendix VI of the 2026 FIA WRC Sporting Regulations.
- b) Additional m² of service space can only be booked for an additional fee per m² and are subject to availability and organisers agreement, also see Point 4.
- c) Any competitor requiring more space and/or a different layout than indicated above must submit his/her request accompanied with the service layout together with the entry form or until the entry closing date at the latest.

5.4.3 Other Competitors:

- a) Service area depending on the size booked with the entry (8x8, 10x10, 12x10 or 14x10), also see Point 4.3. There are no intermediate sizes to the aforementioned areas.
- b) Additional m² of service space can be booked from a size of 14x10 and an additional fee of 25€ per m²+15% VAT to be added and are subject to availability and organiser's agreement, also see Point 4.
- c) Any competitor requiring more space and/or a different layout than indicated above must submit his/her request together with the service layout together with the entry form or until the entry closing date at the latest.

5.5 Environmental Prescriptions

The compliance with the environmental and safety prescriptions (see also Supplementary Event Regulations) will be carefully checked by officials. Please make sure that all team members are aware of these prescriptions.

More details will be published in Rally Guide 2.

5.6 Service

On arrival to their service bays, all drivers will be asked to be accessible to the public for autographs and photos.

For any repairs prior to a re-start (i.e. after a retirement), please see the prescriptions of FIA WRC, Art. 55.

There will be no remote service zones or tyre-fitting zones outside the main service park during the rally. There will be a remote service zone for Shakedown on Wednesday. This is approximately 40kms from Jeddah. More information will be given in the Supplementary Regulations.

6. Two Way Radios

6.1 Applications

All applications to use two-way radios must be submitted prior to the commencement of the event.

To ensure smooth event operations, all radio frequency requirements must be submitted at least 2 months prior to the event, while satellite requirements should be provided 3 months in advance. 7.6 Vendor Shipping Schedule and Documents

Vendors must share the shipping schedule and all the export documents (BL, PL, INV, COO,) with SMC Sporting logistics team before the shipment loading.

7.7 Vendor Logistics Contact Person

The Vendor must introduce his logistics agent to the SMC sporting logistics team before shipment loading to ensure smooth operation and better communication to clear the shipment as soon as it reaches KSA borders.

Any special permits and approvals required, must be requested before shipment departure. The SMC sporting logistics team will reach the concerned party to get the necessary approvals.

- SFDA (Saudi Food and Drug Authority) for live food and first aid and all related communities.
- CITC- CST (Communication. Space & technology Commission) for Radio and communication devices and all related communities.
- MOE (Ministry of Energy) for oil and fuel.
- MOI (Ministry of interior) for fireworks.
- MEWA- (Ministry of environment Water & Agriculture) for plants and live foods.
- GACA – (General Authority of Civil Aviation) for Drones.
- MC- (Ministry of Commerce) for isobar approval.

7.14 Import Bayan

The vendor's custom broker must submit the initial bayan to customs 48 hours before shipment arrival or as soon as the manifest is updated.

7.15 Custom Duties

- Permanent Shipments: According to the agreed shipping terms, the vendor or SMC must pay the customs duty fees and tax for the permanent shipments after the inspection to release them.
- All permanent imports are subject to duties and taxes unless an exemption or concession applies.
- Temporary shipments: Vendor must sign an undertaking letter before we proceed with customs clearance, mentioning that they will be responsible to follow-up and track their shipment on site and they will make sure to re-export the shipment after the event. If the temporary shipment was not re-exported after the time period agreed, the vendor will take the responsibility and will pay the duty and VAT to the Saudi customs.
- After signing the undertaking letter by the vendor, SMC sporting logistics will provide a letter SANADI signed by MOS to the vendor to be shared with Saudi customs to ensure that the shipment will be temporarily imported and re-exported after the event.

7.16 Final Declaration: Import & Export

- Final import bayan to be shared by the vendor with SMC sporting logistics once the shipment cleared and ready to deliver.
- Final re-export bayan to be shared by the vendor with SMC sporting logistics once the shipment cleared and ready to be loaded on board. If the customs agent encounters any issues, vendor must inform SMC sporting logistics immediately.
- SMC sporting logistics will provide a re-export letter to the vendor customs agent once they share with us the pre-export bayan. Only then they can proceed with the clearance process; otherwise, the shipment will be blocked in KSA customs.

9.2 Driving Licence in Saudi Arabia

General Driving Regulations in Saudi Arabia

All WRC Rally Saudi Arabia 2026 participants—including teams, media personnel, support staff and international fans are advised to familiarize themselves with local driving regulations to ensure safe and lawful transit during their stay.

1. Governing Authority

Driving regulations in the Kingdom of Saudi Arabia are overseen by the Public Security Department under the Ministry of Interior.

2. Legal Driving Age

The minimum legal driving age in Saudi Arabia is 18 years.

3. Driving Eligibility for Women

Women are legally permitted to drive in Saudi Arabia.

4. Foreign Driver Licensing

Visitors may drive in the Kingdom under the following conditions:

Holders of a valid International Driving Permit (IDP), or

Holders of a driving license from approved countries, including Gulf Cooperation Council (GCC) nations, the European Union, United States, Canada, Australia, and New Zealand.

Such licenses are valid for use in Saudi Arabia for up to one year from the date of entry.

Please ensure all drivers carry their license, IDP (if applicable), and valid passport or residency documentation when driving.

9.3 Visa Procedure

- Tourist visas will not be accepted for work purposes. All participants must apply for a Work Visa through Saudi Motorsport Company (SMC) to obtain the appropriate status.
- Only single-entry Work Visas will be issued. These visas are strictly limited to WRC- related activities and cannot be used for any other work assignments. Multiple-entry visas will not be granted.
- Each team, media outlet, and TV crew must submit a duly completed Visa Application Form, along with the following documents:
 - A copy of the passport (to be used for travel) & a headshot photo
 - All additional details as outlined in the E-Visa Application Process document
 - All documents must be submitted together, and each file should be clearly named as instructed with the subject line of the email as: WRC26 Rally Saudi Arabia to visa@saudimotorsport.com

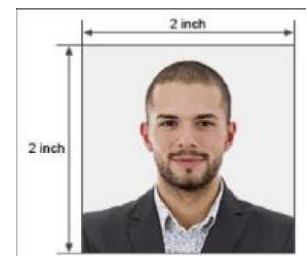

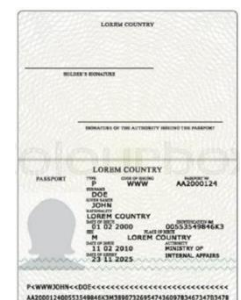

9.5 Passport Requirements

- In all circumstances the passport that the visa was issued on must be presented at passport control.

- Dual nationality passport holders must ensure they enter with the correct passport that visa was issued to.
- In addition, anyone entering KSA must present a passport that has a minimum of 1 year remaining before the expiry date.
- If the passport is issued the visa to does not meet this requirement i.e. it expires within a year, then
- The visa holder must ensure on arrival they have (1) the passport that the visa was issued to and (2) a newer passport that does not expire within 1 year.
- For individuals arriving for the first time to KSA, ensure that a number is written in your passport

10. Reconnaissance

10.1 Reconnaissance Date

Reconnaissance will take place on **Monday, 9 November, and Tuesday, 10 November 2026**.

10.2. Registration Procedure

Prior to reconnaissance, all crews must complete a registration form and collect a reconnaissance pass and a recce vehicle identification at the Rally Headquarters (see Point 3). The material will be given to the drivers personally or to the nominated competitors representative.

10.3. Summary of Specific Regulations and Instructions for Reconnaissance

Participation in reconnaissance only

Any driver wishing to take part in reconnaissance only (see also Art. 35.5 of the 2026 FIA WRC Sporting Regulations) must complete an application form which is available from the organiser and pay a fee of 2.000 € (VAT to be added). The form should be returned until specified under Point 3.

11. Scrutineering, Sealing & Marking

Location: Service Park, Car Parking, Jeddah Corniche Circuit

Time: Individual times to be confirmed in a Bulletin

11.1 Preparations

The homologation form of the rally car and certificates of the roll cage must be brought to scrutineering. The bodyshell and engine will be marked with a special device and the competitor must prepare their car (in a visible place) in order to fit a wire, a plate and a seal on the engine block.

All cars equipped with a turbocharger and their spares (if any) must be marked. All FIA and WRC priority drivers must seal their transmissions and spares (if any).

11.2 Mud Flaps (Appendix J Article 252.7.7)

Fitting of transversal mud flaps (all wheels) is mandatory in conformity with Art. 252.7.7, Appendix J of the FIA International Sporting Code.

11.3 Windows / Nets (Appendix J Article 253.11)

The use of silvered or tinted windows is authorised in accordance with Art. 253.11, Appendix J of the

FIA International Sporting Code.

11.4 Drivers' Safety Equipment

Drivers' safety equipment will be checked at scrutineering. Details on the safety equipment can be found in Appendix 5 of these regulations. Competitors are reminded that two belt cutters must be always carried on board. They must be easily accessible to driver and co-driver when seated with their safety belts fastened (Art. 253-6.1.2, Appendix J).

Each competing car must carry a red "SOS" sign and on the reverse a green "OK" sign measuring at least 42 cm x 29.7 cm (A3), in conformity with the 2026 FIA WRC Rally Sporting Regulations, Article 53.2.

Drivers and co-drivers who wear full-face helmets must contact the Chief Medical Officer in order to carry out a test before the start of the event. This test is described in Appendix L, Chapter III, Art. 1.3.

11.5 Noise Level

At any time on the road sections, the noise level must be in conformity with Appendix J. See also 2026 FIA WRC Rally Sporting Regulations Art. 18.3.

11.6 Special National Requirements

Each competing car must be equipped with a first aid kit and one reflective triangle and two reflective jackets. This equipment will be checked at Scrutineering and may be checked during the event

12. Start & Finish Procedure

12.1. Ceremonial Start Procedure

Date & Time: Wednesday, 11 November 2026, from 20:30

Location: ROSHN Waterfront - Jeddah Corniche

Note: All crew members are required to wear their approved overalls for the ceremonial start.

12.2. Finish Procedure

The competitive section of the rally concludes at TC 16A (Parc Fermé IN). From this point onward, parc fermé regulations will apply to all vehicles until officially opened by instruction of the stewards.

12.3. Car Pick Up from Final Parc Fermé

A car may only be removed from the final parc fermé by the driver or their representative upon presentation of the parc fermé pass issued with the rally materials, and only after the stewards have officially authorised its opening.

Please note: Security will no longer be provided one hour after the final parc fermé is opened.

13. Media Details

13.1 Media Centre Location

A dedicated Media centre will be available for all accredited media professionals, located at the Service Park, located at Car Parking, Jeddah Corniche Circuit.

The facility will be equipped with:

- High-speed internet
- Power supply and charging points – Plug Type: Type G - which is the plug that has three rectangular pins in a triangular pattern like that of UK, Singapore, UAE.
- Basic refreshments

13.2 Media Accreditation

The FIA will manage the media accreditation process through a dedicated online registration portal through a FIA Link, as highlighted in Section 3.

No advertising, public relation agency or similar company or organisation will be accredited as media. Nor will the rally issue any media accreditation to representatives (press officers or otherwise) of sponsors, suppliers, teams, drivers etc. Exemptions will be made solely by the FIA WRC Media Delegate.
